



Urgent Action Grants – Request for Applications (RFA)

Please review the following requirements carefully. Incomplete applications will not be considered.

Through the **Southern HIV Impact Fund**, AIDS United (AU) will award urgent action grants to organizations that execute short-term strategies that advance a positive and supportive socio-political environment in communities across the U.S. South. There is no deadline for submission of requests; applications will be considered on a rolling basis. Grant applications should:

- Advance the rights and well-being of people who face disproportionate structural inequities including, but not limited to: women, people of color, queer people, and people of trans experience;
- Detail a project in one of the following fields: (1) policy, advocacy, and/or mobilization; (2) HIV prevention; (3) HIV care and support services;
- Have a social/racial justice framework and related HIV focus;
- Respond to a time-sensitive and/or urgent opportunity; and
- Implement all project activities within three months of award payment.

To be eligible, the project or organization must have a committed staff member located in one of the following southern states:

Florida
Georgia

Louisiana
Mississippi
North Carolina

South Carolina
Tennessee
Texas

Grant funds may **not** be used for:

- X** Direct or grassroots lobbying (please see [Explanation of Lobbying Activities](#));
- X** Medications or medical care;
- X** Facility acquisition or renovation;
- X** Deficit reduction or debt payment;
- X** Displacement of existing funding sources;

To apply for an urgent action grant through the Southern HIV Impact Fund, please provide all information requested below and submit the following application via email. 2. A summary **project budget** using [this template](#) including anticipated expenses and any other sources of revenue to be used in support of the activities outlined in your proposal. All proposal requests that include lobbying funds must distinguish the lobbying and non-lobbying portions of the budget proposal.
3. An overall **Organizational Budget** (or **Fiscal Sponsor's Organizational Budget**, if applicable).
4. **Photos, videos, articles, media and web links** are also welcome (but not necessary) as part of your application if they help to illustrate your work or the urgency of your request.

Grant awards may only be used for charitable or educational purposes consistent with the tax-exempt status described above. The Organization agrees not to intervene in any election or support or oppose any political party or candidate for public office, or engage in any lobbying not permitted by IRC section 501(c)(3) or, if applicable, IRC sections 501(h) and 4911.
